

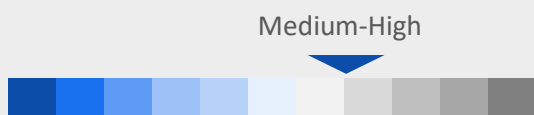
STRATEGY

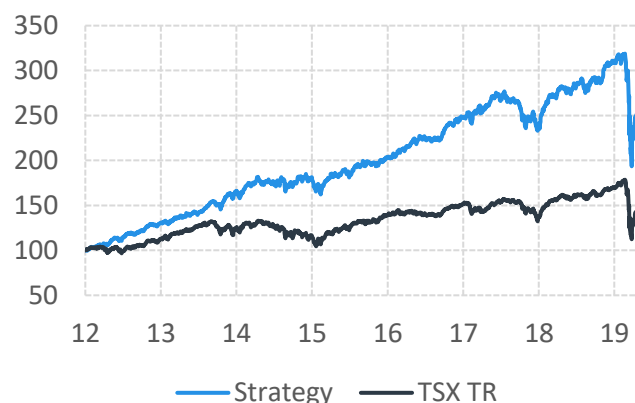
