## FACTOR-BASED MODEL PORTFOLIO STRATEGY



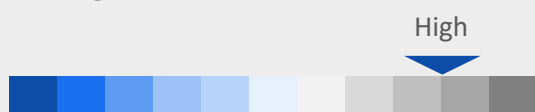
### STRATEGY
