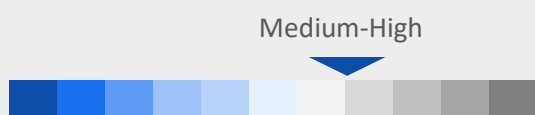
STRATEGY

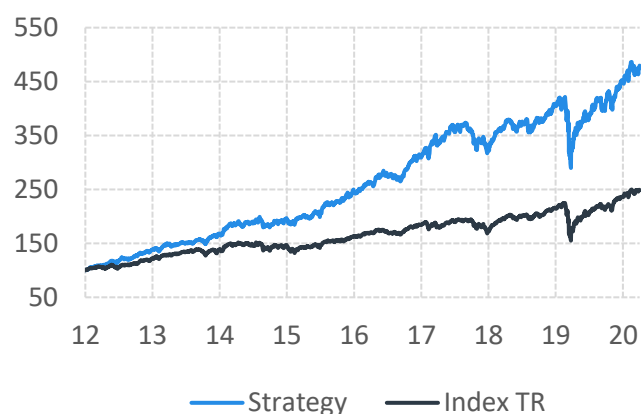

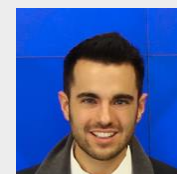
