

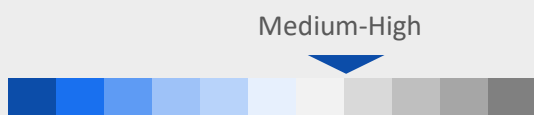
## STRATEGY

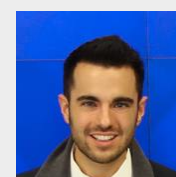
