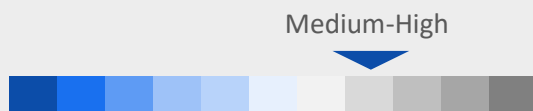
## STRATEGY

3. Maximize tax efficiency by using very liquid and low fee US listed ETFs.

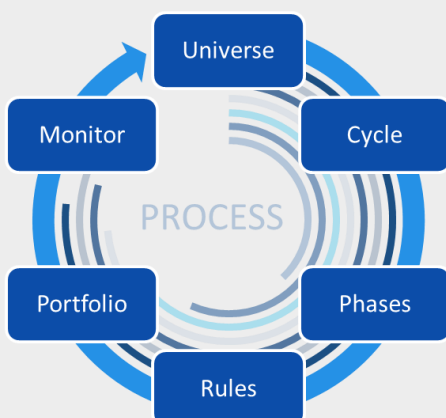

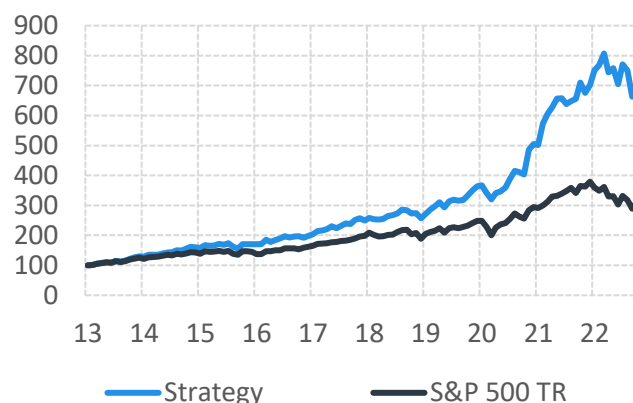

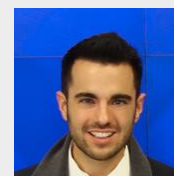
