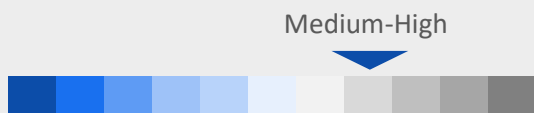
## STRATEGY

3. Maximize tax efficiency by using very liquid and low-fee US-listed ETFs.

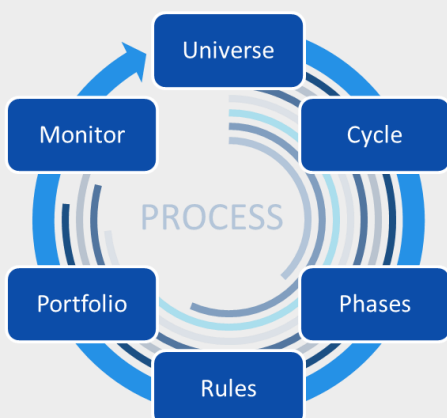

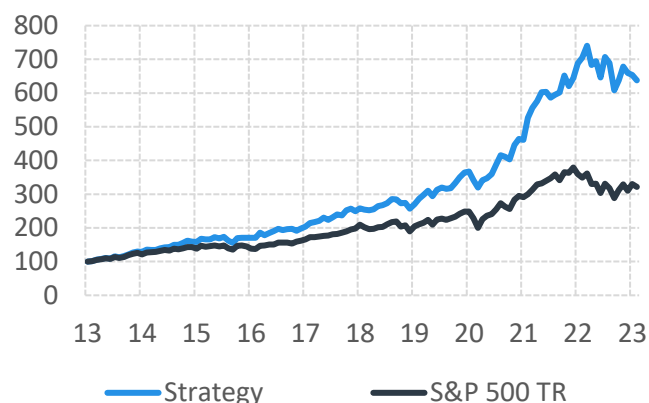

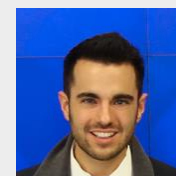
