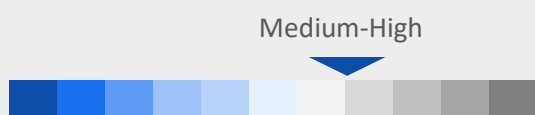
STRATEGY

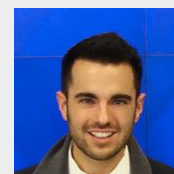
