

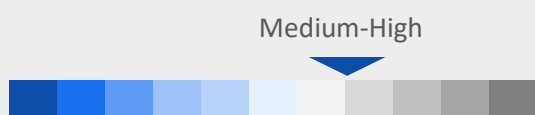
### STRATEGY

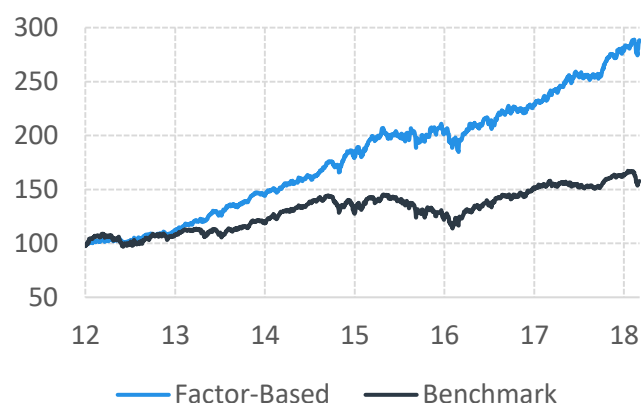
